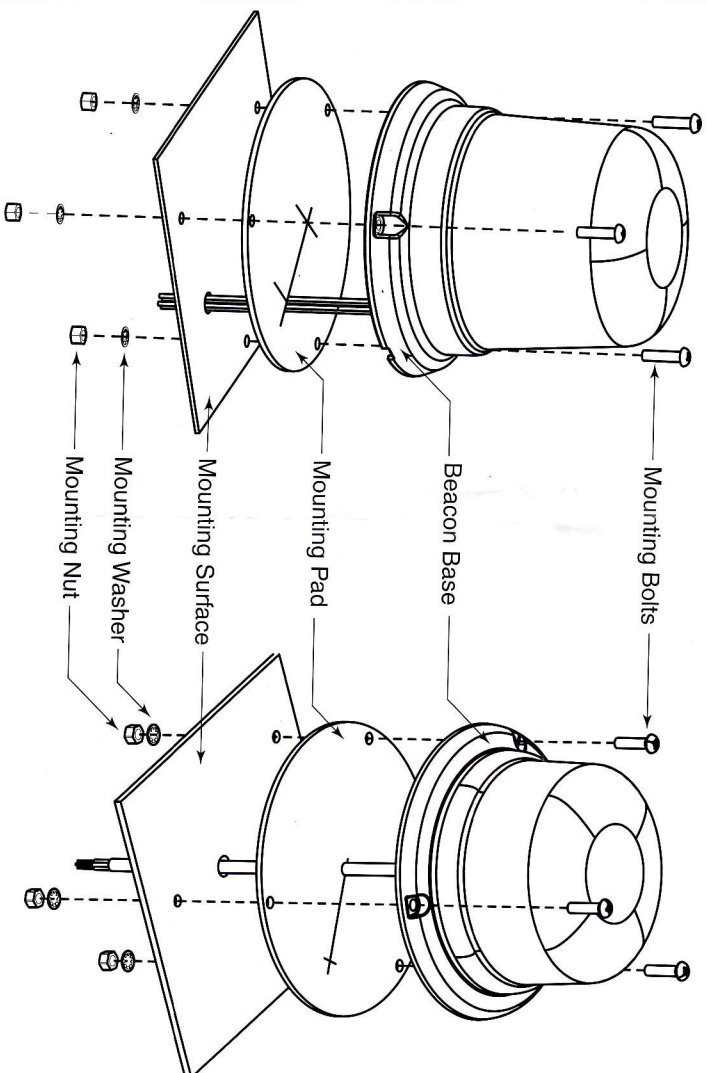


INSTALLATION — FLANGE BASE

- 1 Prepare a suitable area on the vehicle's surface by wiping it clean to prevent scratching.
- 2 Drill a 10mm (3/8") hole into the surface for the wires to exit through for connection to a power source. Alternatively, the wires can be directed through the side of lamp's base for connection to a power source.
- 3 Using the lamp as a template, drill three holes for fitment and secure to the surface using the supplied mounting bolts. A mounting pad is included and can be installed between the surface and the lamp.
- 4 Route the wires as planned in step 2. Connect the red (+) wire to 12/24VDC and the black (-) wire to ground. Test.

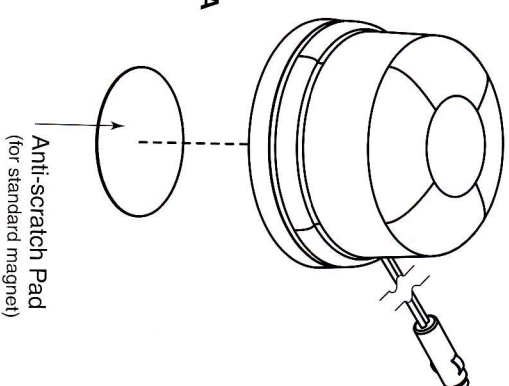

INSTALLATION — MAGNETIC BASE

- 1 Position lamp on a suitable surface and ensure the lamp is secure.
- 2 Insert cigarette plug into a suitable cigarette lighter socket.



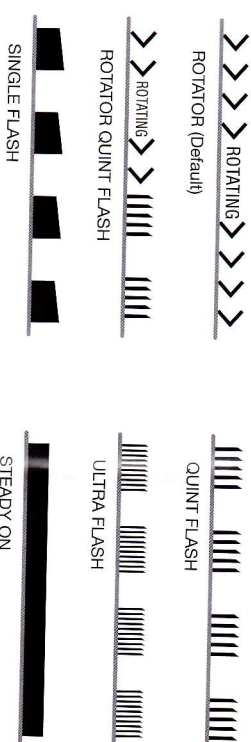

BLACK: To chassis ground (-)

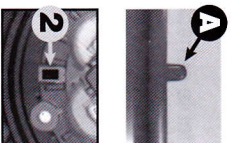
FLASH PATTERNS

The unit comes with 6 user-selectable flash patterns:

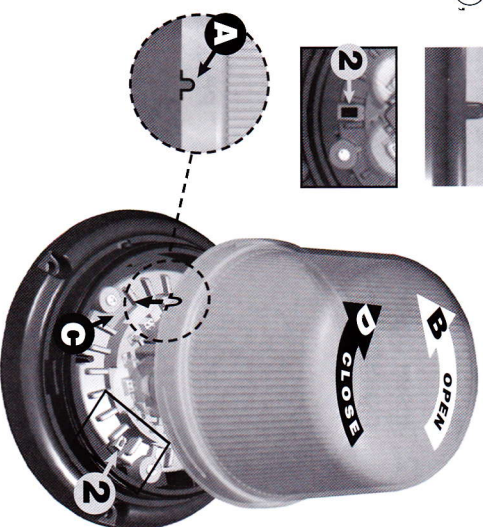


ADJUSTING FLASH PATTERN – FLASH PATTERN ADJUSTMENT SWITCH (Flange & Magnetic Base)

- 1 Open beacon – Push down on **A**, and twist dome counter-clockwise **B**, then lift dome to open.
- 2 Change pattern – Momentarily push red button to change to next flash pattern (see flash patterns chart below).



- 3 Close beacon – Align dome indent **A** to the ribless screw **C**, then twist clockwise to close **D**.
